

JanusID Privacy Statement

About us

JanusID B.V. (“JanusID”) is a Netherlands registered company under number 65206231 located at Benoordenhoutseweg 21-23, 2596 BA The Hague (NL). JanusID operates several websites including www.janusid.nl and www.j-id.nl (“Websites”).

This privacy statement governs the collection, use and other forms of processing of personal data on our Websites and your JiD account. JanusID has notified this registration to the Dutch Data Protection Authority “Autoriteit Persoonsgegevens”.

Thank you for taking the time to read our privacy statement. Your privacy is important to us; therefore, we have a few fundamental principles:

- You control the contents, access and use of your personal data.
- We only use your personal data when this is essential to deliver our services.
- Your personal data may only be shared with anyone after your explicit consent or under a legal obligation.

1. Website Visitors

- a. We collect non-personally identifiable data of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request.
- b. Our purpose in collecting non-personally identifiable data is to better understand how visitors and customers use our products.
- c. From time to time, we may aggregate non-personally identifiable data, for instance by creating a report for internal purposes on trends in the usage of our services.

2. Collecting personal data

- a. Certain users or visitors of our Websites choose to interact with us in ways that requires us to collect their personal data. The amount and type we collect depends on the nature of the interaction.
- b. In each case, we collect such data only insofar as is necessary or appropriate to fulfil the purpose of the user’s interaction with us.
- c. Visitors can always refuse to provide personal data, with the caveat that it may prevent them from using certain features.

3. What data do we collect?

- a. Depending on your use of the Websites, we collect certain personal data from you. This may include but is not limited to:
 - i. Your chosen name (e.g. nickname)
 - ii. Your formal name, first and middle name(s)
 - iii. Gender
 - iv. Date of birth
 - v. Address
 - vi. Telephone number(s)
 - vii. E-mail addresses
 - viii. Passport number
 - ix. Drivers Licence number
 - x. Identity card number

- xi. Place of birth
- xii. Nationality
- xiii. Photos of you that you provide through our app (e.g. selfies or ID pictures)
- b. Whenever possible we aim to minimize the amount of personal data collected. This may be accomplished by connecting your account to other, primary sources of your personal data (i.e. 'Data Federation').

4. What we do with the data we collect

- a. We collect data from you to have your identity verified by Mitek Inc, a global leader in mobile capture and identity verification software solutions. For this they will:
 - check the contents and validity of your chosen identity document, and
 - match your live photos and/or video with the identity document to ensure it's really yours.
- b. We also collect data from you that enables us to contact you by email and/or phone. We will not contact you for unsolicited marketing purposes, and only if there is a certain need (e.g. to inform you about our terms of service, to respond to your technical or service queries, etc.).

5. Data sharing by us

- a. The data you provide to us will not be disclosed to parties other than those we work with to deliver the services. These parties will be made known to you upfront;
- b. We may disclose your personal data where we have your permission or where we have a duty to share it to comply with any legal obligations.

6. Your rights to access or amend your information

- a. You can access and update your data any time by logging in to the JiD website www.j-id.nl. This fulfils the requirements as set out in EU's GDPR (art. 15 Right of Access).
- b. If you terminate your account, there will be a 30-day deactivation period. Your existing consents to share data with websites will be revoked immediately at the time of your termination request. During this period, you cannot access your account. After the deactivation period your account will be deleted. Note that certain data will be kept in our records to comply with applicable laws and regulations.

7. Data security

- a. We operate an extensive security policy that dictates that all reasonable efforts are made to ensure that your personal data is protected from unauthorised disclosure or modification.
- b. We host our services and store your data in the European Union.
- c. Before third parties can connect to our services they will be assessed on their data protection and security practice. Each will have an agreement with JanusID stating the terms that apply to make use of our services. However, we do not actively monitor third parties handling of your personal data. If you suspect inappropriate handling of your data by a third party, you can inform us at legal@janusid.nl.

8. Cookies

We only use cookies that enable us to deliver an effective online service. These cookies will not allow you to be tracked or targeted by third parties.

9. Changes to this privacy policy

We may update this Privacy Statement from time to time. A revised statement will be published on our websites www.janusid.nl and www.j-id.nl. Active JiD-users will receive an email notification of such change.
